DESCRIPTION

Artisan® Poly Haze Remover is a newly developed product that replaces conventional mineral and organic acids. It is a non-fuming, phosphate free product used for removing poly haze from paving stones. Artisan also contains an inhibitor that minimizes iron staining. A special surfactant provides detergency properties, which helps this product penetrate the surface as well as the removal of grease and oil stains. It does not contain any hydrochloric, hydrofluoric, bleach, abrasives, caustic, mineral acids or petroleum distillates. Artisan is formulated as a ready to use product.

USES

Use Artisan to remove stubborn poly haze from pavers and other similar type surfaces. In addition to removing poly haze it is also a effective efflorescence, rust and stain remover, without etching, pitting or damaging the surface, mortar joints or grout. Artisan can also be used to remove concrete residue and build up from cement trucks, molds, floors, walls and equipment.

PREPARATION

For best results, test a solution before general use. Although it contains an inhibitor to protect metal surfaces, it is imperative that a test be done prior to general use. Protect polished and test on painted surfaces and allow to dry before general use. Keep away from plants and vegetation.

EQUIPMENT

Apply using acid resistant brushes. Only apply with equipment made of polyethylene or polypropylene. Do not mix or use with any containers, tanks or applicators that are metal construction.

APPLICATION

Poly Haze Remover can be used full strength or diluted with up to 3 parts water. Apply solution onto a dry surface and allow solution stand for approximately 10-20 minutes without drying. Agitate and rinse thoroughly or power wash. Surfaces with thicker build up may require additional dwell time. For surfaces being sealed, neutralize with a mild solution of ION-417 Architectural Cleaner or Artisan Grease & Oil Emulsifier.

PACKAGED

Poly Haze Remover is available in gallons (4/case), 5 gallon pails and 55 gallon drums.

DISPOSAL

Use completely or dispose of properly. Local requirements vary. Consult your local sanitation department or state designated environmental agency.

STORAGE AND SHELF LIFE

Store in original closed containers. Heat reduces the shelf life. Store in a cool, dry place. Store away from alkaline products and oxidizders.
